During the year ended June 30, 2024, the Clinic's records indicate the Clinic served 912 clinic patients, including 268 new patients, with 2,959 clinic appointments and 875 pharmacy patients received pharmacy support. During the year ended June 30, 2023, the Clinic's records indicate the Clinic served 531 patients, including 220 new patients, with 2,798 clinic appointments and 1,152 pharmacy patients received pharmacy support. Services included medical visits, laboratory evaluations, vision screening, patient education, COVID testing, and referral for COVID vaccines. Behavioral health services were initiated at the Clinic through a partnership with Cabarrus Health Alliance and the University of North Carolina, Charlotte. The Clinic's support for food insecurity continued. During the year ended June 30, 2024, the Food Pharmacy program distributed 2,462 pounds of food, valued at \$4,346. During the year ended June 30, 2023, the Food Pharmacy program distributed 6,340 pounds of food, valued at \$7,930. In addition to clinical and pharmacy services, the Clinic provides patient eligibility, enrollment, and care coordination services for Cabarrus County adult residents who are low-income and uninsured as part of Cabarrus County's health care safety net program, HealthNet. During the year ended June 30, 2024, 1,243 individuals were enrolled in Cabarrus HealthNet. During the year ended June 30, 2023, 858 individuals were enrolled in Cabarrus HealthNet.
